

Wi-Fi Baby Monitor




1 / SAFETY INSTRUCTIONS

Strangulation Hazard: Children get STRANGLED in cords. Keep cords out of the reach of children (more than 1m / 3ft away). Never use extension cords with AC adapters. Only use the AC adapters provided.

When using the cot mount, attach out of the reach of the child. Do not use the cot mount when the child starts trying to get up on its hands and knees in a crawling position.









4/ MOUNTING CAMERA


You have three options to mount the camera: on the wall, in the corner, or on the crib.
